In the same way, students may exercise the right to express themselves, orally or in writing, in whichever they prefer of Catalonia's two official languages, Spanish and Catalan, regardless of the language in which the teachers have conducted their classes. The information regarding the language of instruction of each lecture is published on the UB website before the beginning of the academic year.

2.2. Additional information

- A) Incoming students are allowed to select courses from other UB faculties, provided the percentage of credits completed outside the Faculty of Law does not exceed 49%.
- B) Language courses taken at the University of Barcelona might be included in the Student's Learning Agreement, but the final grades for these courses will not be part of the regular Transcript of Records issued by the Faculty of Law. An additional document should be provided by the specific department offering the course.

3. Grading system

The University of Barcelona uses the European system of ECTS credits. A student who enrolls full-time can gain 60 credits in one academic year. One ECTS credit is equivalent to 25 hours of student work, including lectures and practical classes, private study, participation in seminars, projects and practical work, and preparation for and completion of examinations and assessment tests.

Spanish universities use a 10-point grading system, being 5 the minimum passing grade. The correspondence with the ECTS grading scale is shown below:

The qualification "Matrícula d'Honor" is a very special honour granted only to the students with the best marks (10 out of 10 points). This special label can only be awarded to the top 5% of the students in each course (although in practice there are few less than this theoretical 5% limit for these nominations).
