Diploma Legal Studies in Spain (DLS).

Fall semester or Spring semester. 20 ECTS.

The focus of this program is on International Legal Studies, It is completed by two courses on cultural aspects of Spain and Spanish language.

In order to be eligible for the diploma, the student must choose a minimum of 20 ECTS to obtain the DLS which is an in-house degree of Universidad Pontificia Comillas.

Classes are taught in English (except for the Spanish language course).

Duration: minimum one semester, maximum one academic year.

Procedure to apply:











- The students must be nominated as exchange students by their home University. They must fill in the application form phase I. Once the phase II of the online application is open (course selection), the students must select a minimum of 20 ECTS from the diploma list of courses.
- Administrative request of the diploma: before **20 October** for Fall semester and **18 February** for Spring semester, the student must submit the [Diploma request form](#) to internacional.der@comillas.edu
