

### Fall and Spring terms

#### Description

ICADE-SAILS is a program designed by the Law School at Universidad Pontificia Comillas-ICADE for Law students interested in getting international experience without missing qualification in the Law field with their classes. We offer a set of courses in International, European and Comparative Law.

#### Content and structure

The Program lasts between a minimum of one term and a maximum of one academic year. The student can enroll up to 33 credits per semester. The student adapts the curriculum to meet their particular needs and interests, based on their previous studies, the specialism of their current studies and the guidelines received from their home university. For this, they choose subjects from the general range offered on the Program.

The subjects of the Program are taught in English.

The Program is regarded as a parallel or additional offer to that received by exchange students in the regular framework of the exchange programs managed by the International Relations Service and the Faculties. An exchange student at Comillas may simultaneously enroll on this Program while studying subjects as an exchange student. (See [List of ICADE Law School courses](#) for information on additional courses). The enrollment period closes at the same time as the general enrollment period for exchange students.

#### Fees

ICADE-SAILS is part of our student exchange program. No academic fees apply for exchange students. The number of international students and the length of their stays count towards the student exchange balance with our partner Universities.

Free movers from non-partner institutions are obliged to apply for admission. The fees applied are 293 € per ECTS.
