## Dates & Deadlines

OSU's academic year has four quarters, or **terms**, rather than semesters. Each term length is 10 weeks, including the exam period. You can attend OSU for 1-3 terms starting in Fall, Winter or Spring depending upon the exchange agreement that your home university has with OSU.

The application deadline is dependent upon which term you are applying to start.

Exchange students do **not** normally attend OSU in summer term but check with your home school coordinator to see if that is an option.

All exchange students must plan to arrive about **one week before** the first day of the term, as we will welcome all exchange students at the mandatory Orientation meeting before classes begin.

You should expect to stay on campus until the last day of term, as you may have a final exam on that day.

# Information for incoming international exchange students

## Student Fees

No **tuition fees** are charged by OSU to students coming to OSU through the College of Business's International Business Exchange program.

**General mandatory student fees** charged to all students per term is approximately **US\$860**. These fees cover access to recreational facilities, student club participation, use of the Corvallis transit system, and other on-campus student services that you will use while on exchange.

## Health Insurance

All exchange students are required to have full health insurance whilst attending OSU. Health insurance costs for each term of attendance are included in the program fees.\*

\*Providing evidence of having the same level of health insurance coverage from your home country may enable students to submit a request to waive health insurance fees.

## English Language Skills

Advanced English language skills are required for OSU Business courses. Your home university will confirm your English proficiency as part of your application (TOEFL waiver form). We do not offer preparatory English Language courses before the start of the term.

### Living on campus

OSU student housing options vary, depending upon residence hall and room occupancy availability. Prices begin at US\$3300+ per term. A dining plan will cost about US \$1250+ per term.\*

*\*If you cancel your exchange after signing a housing contract with OSU, you may be required to pay cancellation fees depending on when you cancel the contract.*
