

The Boundaries of European Social Citizenship,

On Thursday 29 November 2007 Sandra Mantu was awarded the Hanneke Steenbergenscriptieprijs. This prize is awarded each year for the best thesis on migration law by the Stichting Hanneke Steenbergen Fonds. The Foundation and the Prize bear the name of Hanneke Steenbergen.

The thesis of Sandra Mantu entitled 'The Boundaries of European Social Citizenship' sketches the legal framework within which the debate regarding access to social benefits for economically inactive migrant EU citizens takes place, dealing in detail with the social entitlements of three specific categories: students, retired citizens and unemployed/job seekers.

The thesis, written under the supervision of Elspeth Guild and Paul Minderhoud, tries to answer the question how the principle of solidarity based on the notion of Union citizenship applies in practice for those three categories and how the introduction of Union citizenship has affected the position of each of those groups of citizens.

Op 27 november 2007 vond in Nijmegen een seminar plaats in samenwerking met het Centrum voor Migratierecht en de Taalstudio over het gebruik van de taalanalyse in het asielrecht. Naar aanleiding van dit seminar is dit boek tot stand gekomen.

De taalanalyse is een middel gebruikt door de Immigratie- en Naturalisatiedienst (IND) om duidelijkheid te verkrijgen over de herkomst van een vreemdeling. Een taalanalyse wordt uitgevoerd als er twijfel is aan de gestelde herkomst van een vreemdeling. Wat is een taalanalyse, uit welke elementen bestaat deze; wie verricht een taalanalyse; hoe wordt een taalanalyse afgenomen; wat zijn de mogelijkheden om een contra-expertise te (laten) verrichten; hoe krijgt men hiervoor een vergoeding; de Wet Openbaarheid van bestuur en de taalanalyse; jurisprudentieoverzichten over de taalanalyse; IND-werkinstructies; Guidelines on the use of language analysis.

On October 14th, 2008, a special seminar will be held:

"Between Autonomy and the European Union.

The Europeanisation of National Immigration Policies and Politics"

The Centre for Migration Law organises a seminar on the European influence on national immigration politics, using **Thomas Faist's** recent book "Between Autonomy and the European Union. The Europeanisation of National Immigration Policies and Politics" as a starting point for discussion.

Program

Since the coming about of several European Union directives on immigration law, (e.g. the Directive on Family Reunification, the Union Citizens Directive, the Directive on the qualification as refugees or as subsidiary protected and the Directive on procedures on granting and withdrawing refugee status) legal scholars have plunged into the development of these directives as well as their impact on national immigration policies. Political scientists are also interested in the actual impact of the EU on its member states.

They have studied the development of common political institutions and policies on the supranational European level and the role played by member states in the evolution of European integration. Secondly they have looked from a top-down perspective, taking political structures and policies on the European level for granted, at their effects on domestic structures and policies.

During this seminar we hope to bring the political, legal en socio-legal perspectives together. After an introduction by Thomas Faist, four discussants are invited to reflect on Faists' statements from a legal and socio-legal perspective.
