## NONDISCLOSURE AGREEMENT

- 1) The undersigned knows that he or she is obliged to use any confidential information that he or she becomes aware of in the context of his or her membership of a USR/FSR/OLC exclusively in the context of his or her tasks and to observe secrecy with respect to this information. Confidential information is understood to mean: all information, documents and data that are not yet in the public domain.
- 2) The obligation referred to in paragraph 1 will remain in effect after the membership of a USR/FSR/OLC has ended.
- 3) The obligation referred to in paragraph 1 does not apply, in so far as not agreed upon otherwise, in respect of colleagues or other persons who are jointly responsible for the proper performance of the tasks, if and in so far as they themselves are under the obligation to observe secrecy or undertake to observe secrecy.
- 4) All property rights with respect to the confidential information, and any results based on it, that the undersigned has been provided with in the context of his or her position or work at, or on the instructions of, Radboud University will remain vested in Radboud University.
- 5) The undersigned is neither permitted to have or keep in his or her possession, in whatever way, any confidential information that he or she has received in the context of the performance of his or her tasks under the agreement, nor permitted to copy this information, except where and in so far as this is required in the context of his or her tasks or assignment.
- 6) The undersigned undertakes to return to Radboud University, immediately and without having to be requested to do so, all confidential information referred to in paragraph 1 and any other information in relation to his or her work, together with any (digital) copies and notes of it, when his or her work or assignment ends. This is understood to include all forms of computer software and (digital) data carriers, drawings, documents and/or any other property that is related to the work or assignment.
- 7) The undersigned is aware that any breach of his or her obligation to observe secrecy may result in his or her membership being terminated and/or in a claim for damages as well as in the relevant sanctions being imposed as laid down in the law.
- 8) If there should be any doubt about the applicability and/or the interpretation of the present provisions, the undersigned will hold consultations, on his or her own initiative, with Radboud University; this also applies if he or she becomes involved in proceedings in which anything referred to in the present agreement is or may be at issue.
- 9) This agreement is governed by the laws of the Netherlands.
